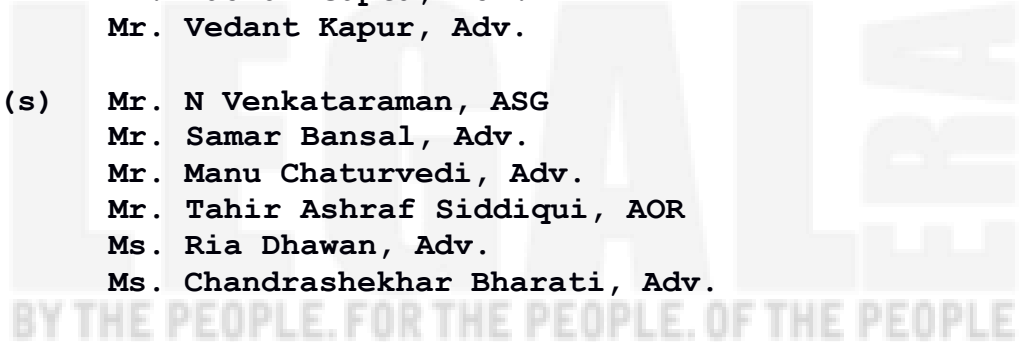

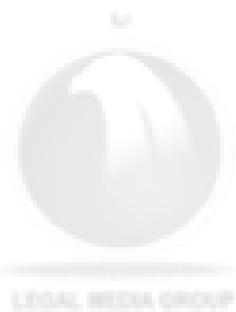
UPON hearing the counsel the Court made the following
